1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.
2. If the bidder is a Startup, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to their meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. 3. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
4. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.
5. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. The buyers are advised to refer to the [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if the credentials of the service provider are validated on-line in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents.
6. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
7. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -
  1. Three similar completed services costing not less than the amount equal to 40% (forty percent) of the estimated cost; or
  2. Two similar completed services costing not less than the amount equal to 50% (fifty percent) of the estimated cost; or
  3. One similar completed service costing not less than the amount equal to 80% (eighty percent) of the estimated cost.
8. Reverse Auction would be conducted amongst first 50% of the technically qualified bidders arranged in the order of prices from lowest to highest. Number of sellers eligible for participating in RA would be rounded off to next higher integer value if number of technically qualified bidders is odd (e.g. if 7 bids are technically qualified, then RA will be conducted amongst L-1 to L-4). In case number of technically qualified bidders are 2 or 3, RA will

be between all without any elimination. If Buyer has chosen to split the bid amongst N sellers, then minimum N sellers would be taken to RA round. In case Primary products of only one OEM are left in contention for participation in RA based on lowest 50% bidders qualifying for RA, the number of sellers qualifying for RA would be increased to get at least products of one more OEM (directly participated or through its reseller) if available. Further, if bid(s) of any seller(s) eligible for MSE preference is / are coming within price band of 15% of Non MSE L-1 or if bid of any seller(s) eligible for Make in India preference is / are coming within price band of 20% of non MII L-1, then such MSE / Make in India seller shall also be allowed to participate in the RA process.

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

**2. Generic**

**Bidder financial standing:** The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

**3. Generic**

1. The Seller shall not assign the Contract in whole or part without obtaining the prior written consent of buyer.
2. The Seller shall not sub-contract the Contract in whole or part to any entity without obtaining the prior written consent of buyer.
3. The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

**TERMS AND CONDITIONS**

- 3.1 The bidder shall provide Two double bed rooms for TOR/Holiday Home for ESIC at Nagpur Maharashtra on a Monthly Rental basis. The size of each room should not be less than 200 sq. feet.
- 3.2 The Holiday Home shall be, in a decent location with greenery around, easily approachable and accessible via public transport with sufficient parking space for the vehicles of the guests.
- 3.3 The accommodation should normally be provided for three adults or two adults and two children (below ten years).
- 3.4 Bedroom shall be provided with a cupboard (with Min 6 hangers).

- 3.5 Bedrooms shall be provided with proper amenities like a sofa and other furnishing. teapot, dressing table with stool, dustbin, etc.
- 3.6 Bedroom shall be provided with a TV (LCD/LED Min-32 inch) with remote and dish connection and internet/ Wi-Fi connection.
- 3.7 Bedrooms shall be provided with an Air Conditioner,
- 3.8 There shall be provision for additional rooms/extra beds.
- 3.9 The bedroom shall have one exclusive bathroom.
- 3.10 The bathroom shall have a toilet.
- 3.11 Bathroom shall have a geyser (ISI Mark), buckets, mugs, floor mats, dustbin, soap, hand wash, shampoo etc,
- 3.12 Water & Electricity shall be supplied 24 hours throughout the year.
- 3.13 There shall be a caretaker/Staff who would also maintain the register for recording the stay of ESIC officials and their families/guests in the allotted rooms.
- 3.14 The cost of the caretaker/staff would not be borne by ESIC.
- 3.15 Necessary arrangements for locking and opening of the rooms shall be made.
- 3.16 Arrangements are to be made to get the room cleaned every day.
- 3.17 The linen of bedding is to be changed every day when the room is occupied.
- 3.18 Curtains are to be cleaned periodically.
- 3.19 The rooms allotted to ESIC shall not be sublet or part with possession of the said premises or any part thereof without first obtaining the written consent of ESIC.
- 3.20 The rooms allotted to ESIC shall normally be kept locked and shall not be normally allotted to use by anyone except ESIC employees/guests who have been officially allotted the rooms for stay. For this purpose, ESIC officials/ guests would carry an official letter. If the rooms earmarked for ESIC are allotted to any other guest, ESIC officials shall be provided similar or better rooms as substitutes.
- 3.21 Income Tax/TDS, as per rules, shall be deducted from the bills of the successful bidder.
- 3.22 ESIC reserves the right to terminate the contract by giving one month's notice.
- 3.23 in the event of a dispute, the decision of the Joint Director I/C, ESIC Sub Regional Office. Nagpur (Maharashtra) shall be final and binding
- 3.24 The Courts at Nagpur alone shall have the jurisdiction in any matter arising out of/relating to or touching this agreement.
- 3.25 Joint Director I/C, ESIC reserves the right to accept or reject summarily any or all tender in whole or in part without assigning any reason whatsoever.
- 3.27 The agreement shall be entered into for a period of One year initially, which may be extended for a further one year, if services are found satisfactory and on mutual consent.
- 3.28 The successful bidder will have the right to terminate the contract by giving three month's notice.
- 3.29 The successful bidder will have to obtain feedback of ESIC guests in the prescribed Performa and enclose all the forms with the monthly bill of TOR/Guest House.
- 3.30 The propose site of Hotel/Guest House/TOR should be on Metro lane or nearby. The priority will be given whose location are available at Metro lane.

Note: The bid shall remain valid for 90 days from the date of opening of the financial bid.

3. SECURITY DEPOSIT Successful bidder will be required to deposit Security Deposit at the rate of 3% of the tender amount for the fulfilment of the contract. The said amount is payable by demand draft in favor of "ESI Fund A/c No 1. Nagpur" or as e-Performance Bank Guarantee which will remain valid for a period of Sixty days beyond the date of completion of all contractual obligations of the tenderer including varied obligations. The security deposit shall be deposited within fifteen days from the date of acceptance of tender, failing which ESIC reserve the right to cancel the acceptance of tender. In the event of any breach of terms and Conditions of the contract, delay, default or any type of lapse on the part of contractor, the contract shall be terminated without assigning any reason and the security deposit or MD, will be forfeited by ESIC. (Necessary exemption may be given as per extant rule)

Penalty Clause: For every Term and Condition disobedience or fault, a penalty of Rs. 1000/- per fault will be deducted from the bill. If the Stay is not provided to the applicant after getting a booking confirmation from hotel/Holiday Home, respective no. of Days rent along with penalty as mentioned above will be deducted. Cumulative Penalty cannot exceed more than 10% of the total contract value. In this case contract will be terminated without a warning.

## Disclaimer/अस्वीकरण

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
